<u>Approve Monthly Town Board Meeting Minutes:</u> Motion was made by Supervisor Wundrock to accept the May 17th Monthly Town Board Minutes as given. A second to the motion was made by Sup. Freeman. Motion carried.

<u>Approve June 7th Special Town Board Meeting Minutes:</u> Motion was made by Sup. Freeman/Sup. Wundrock to approve the June 7th Special Town Board Meeting Minutes (regarding Tank Road). Motion carried.

<u>Treasurer:</u> <u>Approve Monthly Treasurer's Report:</u> Motion was made by Sup. Wundrock/Sup. Freeman to approve the May 31st Treasurer's Report as read. Motion carried.

<u>Budget/Vouchers:</u> <u>Approval & Payment of Vouchers:</u> Motion was made by Sup. Wundrock/Sup. <u>Public Forum - Town of Mukwa Residents:</u> Clerk Zielinski wanted to go on record as being very disappointed about the vandalism recently done to the Wolf River Sturgeon Trail. If anyone has any information please forward to the Waupaca County Sheriff's Department. Tom Handschke-Bean City Road; Questioned whether tree trimming had been completed as he noticed several dead trees on Laib Road (tree trimming will be ongoing). Wayne Poppy-Flying Acres Court; Wants to do a land split on property he owns to put up a new house and was concerned that there are so many rules to follow.

County Supervisor: County Supervisor, Bob Flease mentioned the updated Waupaca County Zoning Map.

Jon Baltmanis-Candidate for State Assembly District #40: Mr. Baltmanis introduced himself and gave a brief presentation on why he is running, his beliefs and personal background. Mr.Baltmanis asked the Board's permission to allow those present to sign his nomination papers after the meetings conclusion and thanked everyone present.

<u>Plan Commission</u>: (a)<u>Update/Monthly Report</u>: Plan Commission Chairman, Lee Shaw reported that at the June 2nd meeting, Steve & Amy Wieckert were present and spoke regarding the possibility of opening the Nysee pit on Beckert Road, questions were answered-this pit contains farm and mason sand. Once all product removed, it will become a subdivision. Final Reclamation Plan is still needed from East Central Wisconsin Regional Planning Commission. Plan Commission members worked on the Comprehensive Outdoor Recreational Plan – change priorities, such as Wolf River Sturgeon Trail, the Town Hall, remove Ostrander. Again, this plan needs to be in place for the Town to be eligible for any grants. A Public Hearing will be held on July 7th at 6:00 p.m. regarding the Wieckert pit and the Waupaca County Zoning Ordinance and Maps. Motion was made by Chairman Curns/Sup. Freeman to accept the Plan Commission Chair's Report. Motion carried.

<u>Approval of Application for Minor Land Division/Certified Survey Map:</u> (a) <u>Wanda Graham:</u> Motion was made by Chairman Curns, seconded by Supervisor Wundrock to approve the Certified Survey Map for Wanda Graham and Chris & Brenda Ott for the property on Lyons Road. Motion carried. (b) <u>Tom McClone, Agent-Corey Prinsen & Robert Schaefer:</u> Not present.

Roads: (a) Monthly Report: Potholes filled. Roads patched. Ditch mowing has been completed. Shouldering should be done as soon as possible. (b)Road Equipment-Report/Repairs/ Purchases Needed: Equipment should be power-washed again. Wash Town Hall. (c) <u>Tank Road-Status of Reconstruction Project:</u> The WIDOT Exception to Standards letter as been approved & signed. The contract was officially awarded at the June 7th Special Town Board Meeting. Tentative start date is July 15th. (d)Other Possible Small Maintenance Projects: Make a complete list of small projects. Mentioned that the culvert at Weyauwega Rd/Broadway Street needs to be replaced, ditch needs to be cleaned out. Motion was made by Sup. Wundrock/Sup.Freeman to have Mid-State Asphalt start work on the culvert & ditch issue contingent upon an acceptable bid. Motion carried. Also the curb at the corner of Church St/Weyauwega Road should be added to the Mid-State bid. (e) Tree Trimming Update: Sup. Wundrock took Mr. Ferg through the Town to show him the projects that need attention, per the Annual Road Viewing. Sup. Wundrock will contact Mid State Tree Service about the trees on Laib Road. (f)Ona Pines Subdivision: Ron & Glenn Miller were present to represent Ona Pines. They are interested in putting an asphalt surface on the roads. Would like the County to do the work, but need to have Town approval. Mr. Miller emphasized this was in the exploratory stage. For the County to do work for a private individual work must be authorized by the Town and bills/payments need to come from the Town. A separate meeting will be set up with all involved parties, including Plan Commission member/s. (g)Snowplowing-Waupaca County Highway Department: Highway Department is interested in doing additional roads-possibly Bean City, Manske, rest of Cut-Off. Need more information to make a decision. Town will give a map and possible proposal. Separate meeting will be set to address this issue further. Motion was made by Sup. Wundrock/Sup. Freeman to pursue an agreement with the County for snow

removal contingent upon acceptable financial arrangement, for Cut-Off Road, Manske (middle & east) Road and the entire length of Bean City Road. Motion carried.
