<u>Approve January 9th Special Town Board Meeting Minutes:</u> Motion to approve the Minutes from the January 9th Special Town Board Meeting was made by Supervisor Shaw with a second by Supervisor Freeman. Motion carried.

<u>Approve Monthly Town Board Meeting Minutes:</u> Motion was made by Supervisor Shaw to approve the December 19, 2011 Monthly Town Board Minutes. A second to the motion was made by Supervisor Freeman. Motion carried.

<u>Treasurer: Approve Monthly Treasurer</u> Report: Motion was made by Supervisor Shaw, seconded by Supervisor Freeman to approve the December 31, 2011 Treasurer

<u>Budget/Vouchers:</u> <u>Approval & Payment of Vouchers:</u> Motion was made by Chairman Curns/Sup. Shaw to approve payment of Vouchers 23862 through 23888, dated January 1, 2012 through January 16, 2012, for a total of \$1,773,183.11. Motion carried.

<u>Public Forum - Town of Mukwa Residents:</u> Tom Handschke-Bean City Road-Advised that the snowmobile club has a four-stroke, two-person, post hole digger (only used once) they want to sell, paid \$800 & asking \$300. Will take a look at & add it to next monthos agenda. Arnie Heise-Faskell Road-Asked if snowplow drivers could plow the intersection of Ostrander/Faskell a little differently so that his driveways & mailbox wouldnot get oburiedo. Mr. Heise would prefer it pushed onto lawn, best to make two passes to clean up that corner.

<u>Plan Commission:</u> (a)<u>Update/Monthly Report:</u> Plan Commission Chair Shaw reported that there was no January meeting. Next Scheduled Meeting (if Needed): Wednesday, February 1st at 6:00 p.m. to be held at the Mukwa Town Hall.

<u>Certified Survey Map Approval/Signature-Judson Isebrands:</u> Motion to approve & sign the Judson Isebrands Certified Survey Map was made by Chairman Curns with a second to the motion made by Supervisor Shaw. Motion carried.

<u>Driftwood Road School Bus Turn-Around Concerns/Follow-Up:</u> Supervisor Shaw went to the County Land Information Office & obtained a better map of the proposed area. Chairman Curns proposed that the Town ask a surveyor to restake the area since the corners exist & we would know the boundaries ó about \$300-\$400. Supervisor Shaw showed that the new map did more clearly show these boundaries. Felt best to not spend any money as this has to go to the Annual Meeting to get the approval of the voters.

Adopt Ordinance 3-11 ó Prohibiting Weapons in Municipal Buildings: Due to additional information received from the Townøs Insurance Company, the Board decided it was not in the Townøs best interest to adopt this Ordinance at this time. It may be adopted in the future.

Roads: (a)Monthly Report: Chairman Curns received the proposal from the Waupaca County Highway Department about annual bridge inspections. Motion to sign the County Highway Department to conduct the bridge inspection was made by Chairman Curns, seconded by Supervisor Shaw. Motion carried. (b)Road Equipment-Report/Repairs/Purchases Needed: Waiting for a part (pulley) for the grader. Hoses replaced on Chevrolet & got a spare. (c)Waupaca County Highway Department-Brushing/Tree Trimming Projects: Supervisor Shaw proposed the following to be cut: Bean City Road-North of Bean City Bar/west side to Hutchison; Manske Road-North side; Ebert Road from E8412-E8428; Klatt Road near E9288 & Ostrander Road from Loss Road also near the Town Line with Royalton. County has a winter program to keep their employees working & felt this would be a good time to try so we can compare with other tree services that the Town has used in the past. Motion was made by Supervisor Shaw to authorize the County Highway Department to do the aforementioned brushing/tree trimming. Second to the motion was made by Supervisor Freeman. Motion carried. (d)Discussion-Transfer Town Half of Beckert Road to City: Follow-up: Chairman Curns spoke with the City again regarding this issue-they need the legal description of the proposed area. Currently the City does all the snow removal. Will be added to future agenda.
