<u>Approve</u>: (a) <u>March 17, 2014 Monthly Town Board Minutes</u>: Motion was made by Supervisor Shaw with a second by Supervisor Manske to approve the March 17, 2014 Monthly Town Board Meeting Minutes as printed. Motion carried. (b) <u>March 21, 2014 Special Town Board Meeting Minutes</u>: A motion to approve the March 21st Special Town Board Meeting Minutes as printed was made by Supervisor Shaw & seconded by Supervisor Manske. Motion carried.

<u>Treasurer</u>: <u>Approve Monthly Treasurer's Report</u>: Read by Treasurer Grove. Motion was made by Supervisor Shaw and seconded by Supervisor Manske to accept the March 31, 2014 Treasurer's Report as read & printed. Motion carried.

<u>Budget/Vouchers</u>: (a)<u>Approval & Payment of Vouchers</u>: Motion was made by Chairman Curns/Supervisor Shaw to approve payment of Vouchers 25079 through 25121, dated March 18, 2014 through April 14, 2014, and Direct Withdrawal of Social Security, Medicare & Federal Taxes of \$907.42, & Wisconsin (Quarterly) Withholding of \$375.38, for a total of \$32,357.37. Motion carried.

<u>Public Forum</u> - <u>Town of Mukwa Residents</u>: Mark Flease-Wolf River Trips & Campground-Cty Trk X was present to speak to the Board about possible road work on Flease Road. The Board asked that this be placed on the May Monthly Town Board Meeting Agenda.

<u>Plan Commission</u>: (a)<u>Update/Monthly Report</u>: April Meeting not required. Next Meeting-TBD & held at Town Hall. <u>Building Inspector</u>: Chairman Curns read. Motion to accept the March-April Building Inspector Report was made by Chairman Curns with a second to the motion made by Supervisor Shaw. Motion carried.

<u>Animal Control Officer</u>: (a)<u>Animal Report Forms/Veterinary Invoice/s</u>: Letter regarding a loose dog was reviewed. (b)<u>Citation Letter/s</u>: None.

<u>Rafts</u>: Letters sent to non-compliant owners were reviewed. Raft Inspector advised of new, local DNR personnel.

Roads: (a) Monthly Report: Road Maintenance Personnel, Jake Jensen advised that a new shoe will need to be welded on the inside of the ditch mower in preparation for the season. (b) Road Equipment-Report/Repairs/ Purchases Needed: It was recommended that a permanent tarp/covering be added to the Sterling to prevent loads/debris from blowing out of the truck. Motion was made by Chairman Curns to purchase/install a tarp kit on the Sterling. The motion was seconded by Supervisor Manske. Motion carried. (c) Tree Cutting/Trimming-Ebert Road/Thompson Road: Clarification from March meeting – Jake will go out & do what he can & will mark trees that he cannot do. (d) Waupaca County Highway Department – Annual Salt Purchases: The decision was requested by the County Highway Department by April 9th; Chairman Curns advised the County, after reviewing purchases; that the Town would like to reserve 50 tons. (Clarification-this does not obligate the Town to purchase 50 tons, but the County needs a solid number from their vendor for next seasons needs.)
