<u>Approve</u>: (a) <u>January 25, 2016 Monthly Town Board Meeting Minutes</u>: Motion was made by Supervisor Shaw with a second by Supervisor Manske to approve the January 25, 2016 Monthly Town Board Meeting Minutes as printed.

Motion carried.

(b) <u>February 12th Special Town Board Meeting Minutes:</u> Motion was made by Supervisor Shaw with a second by Supervisor Manske to approve the February 12th Special Town Board Meeting Minutes. Motion carried.

<u>Treasurer</u>: (a)<u>Approve Monthly Treasurer's Report</u>: Read by Treasurer Grove. Motion was made by Supervisor Shaw and seconded by Supervisor Manske to accept the January 31, 2016 Treasurer's Report as read & printed. Motion carried.

<u>Budget/Vouchers</u>: <u>Approval & Payment of Vouchers</u>: Motion was made by Chairman Curns with a second to the motion made by Supervisor Shaw to approve payment of Vouchers 25929 through 25975, dated January 26, 2016 through February 22, 2016, with Exception of Void Checks #25951, #25953, #25954 & #25955 (*used as copy paper*); and Direct Withdrawal of Social Security, Medicare & Federal Taxes of \$1,074.81, for a total of \$939,235.34. Motion carried.

<u>Public Forum - Town of Mukwa Residents</u>: Arnie Heise-Faskell Road was present to thank the Board for addressing his concerns that Ostrander Road going south toward County Road X was not being properly plowed & sanded & that the pothole on the corner of Loss Road was filled. Pete Popke-Cty. Rd. X asked about a building in Victorian Acres. County Supervisor, Bob Flease-Shaw Road reported that the County Highway Department hired Casey Beyersdorf from Shawano as the new Highway Commissioner & that he should be starting in mid-March.

Rob Ferg-Mid State Tree Service-Hwy 54 – Weight Limit on Broadway Street: Mr. Ferg was present to explain his concern about the Broadway Street Weight Limit & the issues it was causing for his business. Mr. Ferg explained that he & his employees work in New London frequently & it would be much faster for him to be able to use Broadway Street. Mentioned if it would be possible to raise the weight limit to 15-Ton or possibly set it as a "Class B" limit. Discussion on each option. Explained that weight limits are set by Ordinance, this would need to be a specific Agenda item, a newspaper notice & posting before any changes could be made.

<u>Town Hall – Lawnmower:</u> (a)<u>Discussion/Approval of Purchase:</u> Quotes on several lawnmowers were obtained with prices varying from around \$2,000 to \$3,000, also discussed how many times the lawn gets mowed per season & how long it takes. Noted that a Town resident would be willing to mow the lawn for \$50 per mowing. Discussion. A motion was made to hire Charlie Hoffman to mow the Town Hall lawn at \$50 per mowing. A second to Supervisor Shaw's motion was made by Supervisor Manske. Motion carried. (b)<u>Disposition of Old Mower:</u> Town Maintenance, Rick Bunnell mentioned he would be interested in purchasing the old mower if it became available. Chairman Curns made a motion to sell the old lawnmower to Rick for \$50.00, with a second to the motion made by Supervisor Manske. Motion carried.

Adopt Resolution 73-1-16 – In Support of Improved Broadband Internet Access in Waupaca County: Clerk Zielinski read. A motion to Adopt Resolution 73-1-16 – In Support of Improved Broadband Internet Access in Waupaca County was made by Supervisor Shaw with a second to the motion made by Supervisor Manske. RESOLUTION 73-1-16

In Support of Improved Broadband Internet Access in Waupaca County

WHEREAS, improved high speed broadband Internet access is essential infrastructure to Waupaca County and its citizens in order to remain competitive in the 21st Century for economic and community development, business development, tourism development, job creation, communication, public safety, education, healthcare, entertainment, attracting new residents, other current and future uses; and

WHEREAS, according to WI Broadband Now, over 18,000 Waupaca County residents do not have access to the Federal Communications Commission (FCC) minimum standard for download and upload speeds set in January of 2015 for broadband wired Internet service, and approximately 4,000 Waupaca County residents do not have access to any broadband wired Internet service; and

WHEREAS, Waupaca County could be eligible to apply for state and federal grant program funds for the purpose of constructing broadband infrastructure in underserved areas; and

WHEREAS, both public and private sector involvement in the development of a Waupaca County broadband Internet improvement plan is essential; and

WHEREAS, cooperation among county, city, village and town governments will be necessary for partnering with broadband Internet service providers to ensure that all Waupaca County citizens are able to access broadband Internet at speeds meeting or exceeding the standards set by the FCC; and

WHEREAS, the city, village and town governments located in Waupaca County believe that Waupaca County should function as the lead government agency for any cooperative effort at increasing access for broadband Internet service in Waupaca County; and

NOW, THEREFORE, BE IT RESOLVED, that the **Town of Mukwa** supports participating in a cooperative effort that encompasses the local and county governments of Waupaca County for the purpose of creating and funding a strategic plan that implements the deployment of broadband Internet access that meets or exceeds current FCC standards, and, which covers the entire geographic area of Waupaca County.
