Chairman Shaw Opened the Public Hearing for Discussion & Questions: Waupaca County Planning & Zoning Director Ryan Brown & the Town of Mukwa Plan Commission members explained to those present that the "maps" represent Preferred Land Use, not zoning. A majority of the Town is classified as AWT (Agriculture & Woodland Transition) & this will not be changing as a property owner can do more under this classification than if it was RR (Rural Residential). Noted that when a parcel needs to be rezoned, it needs to match the Future Land Use. Resident asked if this change would affect taxes – explained that taxes are not based on zoning, rather what you do with the property. Noted that the classifications for taxes are different than the Land Use/Zoning classifications.

Plan Commission Chair Shaw & County Director Ryan Brown advised that other amendments to the Comprehensive Plan & Land Use Maps will be done throughout the year.
